A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE AN AMENDMENT TO AN OUTSIDE COUNSEL AGREEMENT WITH HANSON BRIDGETT, LLP FOR TAX AND EMPLOYEE BENEFITS LEGAL SERVICES, AND ADDITIONAL FUNDING FOR THE AGREEMENT.

WHEREAS, on June 11, 2012, the San Diego City Council (City Council) adopted San Diego Resolution R-307487 (June 26, 2012), authorizing the San Diego City Attorney to retain Hanson Bridgett, LLP (Law Firm), as outside tax and employee benefits counsel, and approving funding in an amount not to exceed \$250,000; and

WHEREAS, based upon this action, the City Attorney entered into a contract with Hanson Bridgett LLP to provide these services for a period not to exceed five years and in an amount not to exceed \$250,000; and

WHEREAS, the City of San Diego has a continuing need for the Law Firm's expert tax and employee benefits legal advice to establish a permanent defined contribution plan, and death and disability benefits for City employees and elected officers initially hired or assuming office after July 20, 2012; and

WHEREAS, the Law Firm's assistance is also needed to update the City's other qualified defined contribution plans, and to represent the City before the IRS on the City's applications for new determination letters; and

WHEREAS, the City also needs the Law Firm to provide general tax and employee benefits tax advice regarding the City's defined contribution retirement plans and health and welfare plans; and

WHEREAS, the City also needs the Law Firm to provide expert tax advice on an asneeded basis; and

WHEREAS, the Law Firm has billed the City \$208,613 for legal services for June 2012 through May 2014, leaving an available balance of \$41,387 for legal services from June 1, 2014 through the 2015 fiscal year; and

WHEREAS, it is estimated that an additional \$125,000 will be needed for tax and employee benefits legal services for the 2015 fiscal year; and

WHEREAS, due to the unusual and complex nature of the legal issues involved, the City Attorney's Office does not have the necessary expertise to advise the City on the all of these issues; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee and the City Attorney are authorized to amend the Agreement for Legal Services with Hanson Bridgett, LLP for legal services and expenses incurred in providing tax and employee benefits legal service, in an amount not to exceed an additional \$125,000 for a total contract amount of \$375,000.

BE IT FURTHER RESOLVED, that the City Council authorizes the Chief Financial Officer to expend an amount not to exceed an additional \$125,000 in accordance with the Citywide FTE Allocation Schedule for the agreement with outside counsel for the services referenced above, and the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure under established agreement funding are, or will be, on deposit with the City Treasurer.
