A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE CITY OF SAN DIEGO AND THE SAN DIEGO HOUSING COMMISSION FOR THE ADMINISTRATION OF THE CITY'S HOME ENTITLEMENT GRANT PROGRAM AND AUTHORIZING THE CITY'S EXECUTION OF THE MOU.

WHEREAS, the United States Department of Housing and Urban Development has awarded HOME Investment Partnerships Program (HOME) funds to the City of San Diego (City) on an annual basis since 1991; and

WHEREAS, for purposes of the HOME program, the City constitutes a Participating Jurisdiction and the San Diego Housing Commission (Housing Commission) constitutes a Subrecipient as these terms are defined in the Code of Federal Regulations, title 24, section 92.2; and

WHEREAS, the City is designated as the Grantee of the HOME funds and the City's Economic Development Department has oversight and program compliance responsibilities for the City's annual HOME grant; and

WHEREAS, by Resolution No. R-284352, adopted on July 26, 1994, and by Resolution No. R-286709, adopted on December 4, 1995, the City Council of the City of San Diego (City Council) confirmed that the administration, planning, coordination, operation, and implementation of all activities and actions encompassed by the City's HOME program have been delegated to the Housing Commission; and

WHEREAS, on June 26, 2012, the City and Housing Commission entered into a memorandum of understanding for the term of July 1, 2011 through September 30, 2014, which

set forth the operational and administrative roles of the City and Housing Commission for the City's HOME program; and

WHEREAS, on April 30, 2014, the City Council adopted Resolution No. R-308904, which, among other things: (1) confirmed the Housing Commission will continue to plan, coordinate, operate, administer, and implement programs under the City's HOME program, (2) eliminated the Housing Commission's ability to draw down HOME funds for the operation of the City's HOME program, as previously authorized by the City Council in prior resolutions, including but not limited to R-284352 and R-286709, and (3) authorized the Mayor or designee to negotiate and execute agreements, and any and all amendments thereto, with the Housing Commission which set forth the Housing Commission's responsibilities to plan, coordinate, operate, administer, and implement programs for the operation of the City's HOME program; and

WHEREAS, the City and the Housing Commission now propose to enter into a new memorandum of understanding (MOU), a copy of which is included with Report No.

HAR14-032 accompanying this Resolution, to clarify their respective roles and responsibilities for the oversight and administration of the City's HOME program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:
