A RESOLUTION OF THE COUNCIL OF THE
CITY OF SAN DIEGO TO APPROVE AND ADOPT
THE PROPOSED RESPONSE TO THE SAN DIEGO
COUNTY GRAND JURY REPORT ENTITLED
“POLITICS AND WATER DO NOT MIX–THE DARK SIDE”

WHEREAS, on May 20, 2014, the San Diego County Grand Jury filed a report entitled “Politics and Water Do Not Mix – the Dark Side,” which included six findings and seven recommendations; and

WHEREAS, the Council, Mayor, and other respondents are required to provide comments to the Presiding Judge of the San Diego Superior Court on each applicable finding and recommendation within 90 days, and the Court granted a requested extension to October 17, 2014; and


WHEREAS, the Independent Budget Analyst (IBA) has provided input and worked collaboratively with City staff in the Public Utilities Department and the Mayor’s Office to develop a proposed joint response; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the proposed response to the 2013/2014 San Diego County Grand Jury Report entitled “Politics and Water Do Not Mix – the Dark Side,” as prepared by the IBA, is approved and adopted.

2. That the City Council President, on behalf of the City Council, is authorized and directed to execute and deliver the response to the Presiding Judge of the Superior Court by October 17, 2014.


