1. 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$749,750, of which \$20,916 is from Water Operating Fund 700011, \$583,509 is from Metro Sewer Operating Fund 700001, and \$145,325 is from Muni Sewer Operating Fund 700000, solely and exclusively to provide funds for the above contract, contingent on the Chief Financial Officer certifying that the funds are, or will be, on deposit with the City Treasury.
