A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF A COOPERATIVE AGREEMENT WITH THE SAN DIEGO UNIFIED PORT DISTRICT FOR THE NORTH HARBOR DRIVE PEDESTRIAN ACCESS IMPROVEMENTS.

WHEREAS, the City triggered the need for ADA related pedestrian improvements along North Harbor Drive during the construction of Water Department Group Job 532; and

WHEREAS, the San Diego Unified Port District has triggered the need for similar ADA related pedestrian improvements while completing capital projects along North Harbor Drive; and

WHEREAS, the City and San Diego Unified Port District now desire to more efficiently meet their obligations under the ADA and jointly construct needed pedestrian improvements along North Harbor Drive; and NOW, THEREFORE

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, a cooperative agreement with the San Diego Unified Port District, for the purpose of funding the North Harbor Drive Pedestrian Access Improvements, under the terms and conditions set forth in the cooperative agreement, on file in the Office of the City Clerk as Document No. RR 309258.
- 2. That the Chief Financial Officer is authorized to increase the Fiscal Year 2015 Capital Improvement Budget in Annual Allocation A-1K.00001, New Walkways by \$69,850.

3. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$69,850 to be received from the San Diego Unified Port District for the purpose of constructing the North Harbor Drive Pedestrian Access Improvements from Fund 400264, Private & Other Donation Fund, contingent upon the receipt, of a fully executed cooperative agreement and provided that the Chief Financial Officer furnishes one or more certificates demonstrating that the funds for this expenditure are, or will be, on deposit in the City Treasury.

4. That the Chief Financial Officer is authorized to transfer appropriations in Fiscal Year 2015 of \$249,268.14 from ABE.000001, Americans with Disabilities Improvements, Fund 400002, to AIK.00001 New Walkways for the North Harbor Drive Pedestrian Access Improvements.
