A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN INCREASE TO THE CAPITAL IMPROVEMENTS PROGRAM BUDGET FOR THE LA MEDIA ROAD IMPROVEMENTS PROJECT.

WHEREAS, La Media Road is less than 1.5 miles from the Otay Mesa Port of Entry, the largest commercial crossing on the California-Mexico border; and

WHEREAS, commercial truck traffic is expected to double to over 2.8 million annual trucks crossing by the year 2025; and

WHEREAS, this action will allocate \$6.2 million from Otay Mesa-East and Otay Mesa-Eastern DIF funds for the purpose of widening La Media Road to a six-lane facility north of Airway Road and a five-lane facility from Airway Road to Siempre Viva Road; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer is authorized to add CIP S-15018, La Media Road Improvements, to the Capital Improvements Program; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP S-15018, La Media Road Improvements and to appropriate and expend an amount not to exceed \$6,256,690, of which \$5,193,690 is from Fund 400092, Otay Mesa-East, and \$1,063,000 is from Fund 400100, Otay Mesa Eastern DIF, for the purpose of design of La Media Road Improvements Project, contingent upon the Chief Financial Officer furnishing a certificate certifying that all funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.
