DATE OF FINAL PASSAGE OCT 21 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO DECLARE A WATER EMERGENCY
DROUGHT RESPONSE LEVEL 2 - DROUGHT ALERT
CONDITION. PURSUANT TO SAN DIEGO MUNICIPAL
CODE SECTION 67.3806

WHEREAS, the State of California is experiencing one of the most severe droughts on record, prompting California Governor Jerry Brown to declare a drought emergency in California on January 17, 2014; and

WHEREAS, on July 1, 2014, the City of San Diego implemented a "Drought Response Level 1 - Drought Watch Condition" and enhanced City outreach efforts to promote voluntary and mandatory drought conditions and the urgent need to conserve water; and

WHEREAS, on July 28, 2014, the State Water Resources Control Board imposed regulations calling for statewide mandatory water use restrictions; and

WHEREAS, based on the ongoing water supply conditions within the State of California, it is recommended that the City of San Diego move to a Drought Response Level 2 - Drought Alert Condition, effective November 1, 2014; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That, due to drought, a consumer demand reduction of up to 20 percent is required in order to ensure that sufficient supplies will be available to meet anticipated demands per San Diego Municipal Code Section 67.3806(a).

2. That the Mayor or his designee is hereby authorized to declare and implement a Drought Response Level 2 - Drought Alert Condition pursuant to Municipal Code section 67.3806, effective November 1, 2014.

3. That the Mayor or his designee is hereby authorized to enforce water use restrictions as set forth in Municipal Code sections 67.3803, 67.3805 and 67.3806 as part of the City's Drought Response Level 2 - Drought Alert Condition.

4. That the Public Utilities Department will implement a public information outreach campaign to inform residents of the Drought Response Level 2 - Drought Alert Condition mandatory water use restrictions.




