WHEREAS, the San Diego City Council has approved the Articles of Incorporation and Bylaws for the Horton Plaza Theatres Foundation (Foundation); and

WHEREAS, the Mayor and Council have had the opportunity to submit proposed nominees for appointment to fill the new position on the board as a Council appointee to the Horton Plaza Theatres Foundation Board of Directors; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment by the Council, to serve as a member of the Board of Directors of the Horton Plaza Theatres Foundation, for a term ending as indicated, is made and hereby confirmed:
