A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RECOGNIZING A COMMUNITY PLANNING GROUP FOR THE BARRIO LOGAN COMMUNITY, APPROVING THE PLANNING GROUP BYLAWS, AND ITS INITIAL MEMBERSHIP.

WHEREAS, Council Policy 600-24 of the Council of the City of San Diego requires that the original bylaws for each community planning group and initial membership and terms be approved by the Council; and

WHEREAS, Council Policy 600-24 requires that these bylaws follow the format of its standard operating procedures and responsibilities and be in conformance with the criteria contained within; and

WHEREAS, these bylaws allow certain members representing specialized interests to be appointed to the Planning Group, rather than elected by the community at large in order that board membership be as representative of community demographics and property owner/resident interests as possible; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that it approves the Barrio Logan Community Planning Group Bylaws and initial membership and terms, a copy of which is on file in the office of the City Clerk as Document No. RR- 309286.

BE IT FURTHER RESOLVED, that it finds that the initial conditions have been met in accordance with Council Policy 600-24 for the Barrio Logan Community Planning Group to receive official recognition by the City of San Diego.
