WHEREAS, the purpose of this project is to provide upgrades to Fire Station 38 to better serve the Mira Mesa Community; and

WHEREAS, this project is located at 8441 New Salem Street, San Diego, CA 92126; and WHEREAS, this project's scope includes a 637 square-foot addition to the existing fire station to accommodate the Emergency Medical Service staff living quarters and increase operational needs, which includes a new dormitory and restrooms for the fire station crew, and Americans with Disabilities Act (ADA) upgrades to an existing restroom; and
