A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN JANE DOE AND THE CITY OF SAN DIEGO

WHEREAS, on February 9, 2012, JANE DOE filed suit against the City of San Diego [City] alleging personal injuries arising from an incident which occurred on March 8, 2011.

Plaintiff brought suit in the San Diego Superior Court, and defendants later removed the case to the United States District Court for the Southern District of California. The suit is entitled *Doe, Jane v. COSD, et al.*: USDC 12cv00689-MMA (DHB), Case No 12-cv-00689-MMA (DHB)[Litigation]; and

WHEREAS, in Closed Session on August 7, 2014, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 6, 7 and 8; Nays, None; and absent, Districts 5 and 9, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement;

WHEREAS, the City and its insurance carriers are still calculating the final cost of the City's contribution to the settlement;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

1. The Mayor or his designee to pay the sum of \$5,900,000 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising

from the personal injury claim of Jane Doe, U.S. District Court Case Number: 12cv00689-MMA (DHB);

- 2. The Chief Financial Officer to appropriate and expend \$5,900,000 from the Public Liability Fund, Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer;
  - 3. The Comptroller to issue checks as follows:
- a. A check for the amount of Two Million One Hundred Fifty Thousand Dollars
   (\$2,150,000), made payable to Dicks & Workman Client Trust Account for Jane Doe;
- b. A check for the amount of Seven Hundred and Fifty Thousand Dollars (\$750,000) made payable to BHG Structured Settlements, Inc.; and
- c. A check for the amount of Three Million Dollars (\$3,000,000) made payable to Dicks & Workman Attorneys at Law, APC.
