A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CITY ATTORNEY TO RETAIN HAIGHT, BROWN & BONESTEEL LLP FOR LEGAL SERVICES IN CONNECTION WITH *FLORES V. CITY OF SAN DIEGO, ET AL.* (USDC 14CV2202 W (JLB), AND RELATED CASES, FOR THE DEFENSE OF FORMER SAN DIEGO POLICE OFFICER DONALD MONCRIEF

WHEREAS, the City Council has determined that a conflict of interest exists between the City of San Diego and former San Diego Police Officer Donald Moncrief; and

WHEREAS, former San Diego Police Officer Donald Moncrief and the City of San Diego have been sued in the case *Angelica Flores v. The City of San Diego and Donald Moncrief*, (USDC 14 CV2202 W(JLB) for federal law claims;

WHEREAS, in Closed Session on October 21, 2014, the City Council authorized, by the following votes: Yeas, Districts 1, 2, 3, 4, 6, 7, and 8; Nays, None; and absent, Districts 5 and 9, a legal services agreement between the City of San Diego and Haight Brown & Bonesteel LLP in connection with the defense of the civil litigation against Mr. Moncrief for an amount up to \$250,000.00 in legal fees and costs;

NOW, THEREFORE, BE IT RESOLVED, that the Chief Financial Officer is authorized and empowered to execute, for and on behalf of the City, an agreement with Haight, Brown & Bonesteel LLP for the purposes of the defense of the civil litigation against Mr. Moncrief, for an amount up to \$250,000.00 from the Public Liability Fund 720045, solely and exclusively for the purpose of providing funds for the above-described legal services and litigation expenses.

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized and empowered to appropriate up to \$250,000.00 from the Public Liability Fund to meet this obligation.
