A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE
AND FILE APPLICATIONS AND DOCUMENTS FOR THE
PURPOSE OF OBTAINING CERTAIN FEDERAL AND STATE
FINANCIAL ASSISTANCE.

WHEREAS, the California Governor's Office of Emergency Services requires a resolution designating City officials who are authorized to execute and file, for and on behalf of the City, applications and documents for the purpose of obtaining financial assistance to aid the City in recovering costs associated with a declared local emergency; and

WHEREAS, this resolution updates and replaces Resolution No. R-304717 adopted March 20, 2009, which authorized designated City officials to execute and file, for and on behalf of the City, applications and documents for the purpose of obtaining certain federal financial assistance under Public Law 93-288, as amended by the Robert T. Stafford Disaster Assistance Act; and

WHEREAS, this action is needed to update the authorized agents list to include the Mayor, the Chief Operating Officer, The Chief Financial Officer, the Fire Chief, and the Office of Homeland Security Program Manager; and

WHEREAS, funding received from financial assistance programs directly support the City's ability to respond to and recover from a catastrophic event; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Mayor, the Chief Operating Officer, the Chief Financial Officer, the Fire Chief, and the Office of Homeland Security Program Manager are authorized to execute and file, for and on behalf of the City,

applications and documents for the purpose of obtaining certain federal and state financial assistance.


