A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE CONCESSION AGREEMENT WITH NINE DRAGONS, INC., FOR THE OPERATION OF A CAFÉ AT THE CENTRAL LIBRARY IN DOWNTOWN SAN DIEGO IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15301.

WHEREAS, the City of San Diego (City) is considering authorizing and directing the execution of the Concession Agreement on file in the Office of the City Clerk as Document No. \$\overline{\chi}\overline{309317}\$, with Nine Dragons, Inc., a California corporation, for the operation of a food and beverage café at the City's Central Library in Downtown San Diego (Library); and

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, Section 15000 et seq.) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of Projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Development Services Department has established that the Concession Agreement is categorically exempt from CEQA pursuant to CEQA Guidelines section 15301 and

that no exception to the exemption, as set forth in CEQA Guidelines section 15300.2, applies to

the Concession Agreement; and

WHEREAS, the Council of the City of San Diego has considered the potential

environmental effects of the Concession Agreement, and

WHEREAS, the City Council held a duly-noticed public meeting and considered the

written record for the Concession Agreement as well as public comment; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has

determined that the Concession Agreement will not have a significant effect on the environment

because the Concession Agreement entails an interior café and lease operation within the scope

of the existing Library facility and will involve negligible and no expansion of existing uses of

the Library; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Concession

Agreement on file in the Office of the City Clerk as Document No. 29317, with

Nine Dragons, Inc., a California corporation, to operate a food and beverage café at the City's

Central Library in Downtown San Diego, is categorically exempt from CEQA pursuant to CEQA

Guidelines section 15301 and that an exception to the exemption does not apply under CEQA

Guidelines section 15300.2.
