A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXTENSION OF THE CONTRACT WITH KEMIRA WATER SOLUTIONS TO PROVIDE FERRIC CHLORIDE FOR WATER AND WASTEWATER FACILITIES; AND TAKING RELATED ACTIONS.

WHEREAS, the City of San Diego has an agreement with Kemira Water Solutions (Kemira) for provision of ferric chloride to the Public Utilities Department, under the terms and conditions of ITB 10045337-14-C; and

WHEREAS, the expenditures under that agreement are on track to exceed \$1,000,000 for the first year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor, or his designee, is authorized to amend the contract with Kemira for ferric chloride and is further authorized to exercise the four options to extend the contract for additional one-year periods, for a total cumulative expenditure amount not to exceed \$19,175,945 over a maximum five-year duration, under the terms and conditions set forth in the document filed with the City Clerk as Document No. RR-309322, contingent upon the Chief Financial Officer furnishing one or more certificates demonstrating that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
- 2. That the Chief Financial Officer is authorized to expend a cumulative amount not to exceed \$19,175,945, of which \$11,009,958 is from the Metro Sewer Utility Fund 700001 and \$8,165,987 is from the Water Utility Fund 700011, for the purpose of providing funding for the aforementioned Kemira ferric chloride contract and extension options over a contract term not to

exceed five (5) years, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates demonstrating that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
