A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO ALLOCATE COMMUNITY DEVELOPMENT
BLOCK GRANT FUNDS FOR VARIOUS STREET
IMPROVEMENTS.

WHEREAS, the Community Development Block Grant (CDBG) program is a federal program that provides communities with resources to address a wide range of unique community development needs; and

WHEREAS, one of the goals of the CDBG program is to strengthen neighborhoods by investing in the City's critical public infrastructure needs and to support neighborhood safety and improved livability; and


WHEREAS, sidewalks and traffic calming measures are critical public infrastructure to improve the safety and livability of neighborhoods; and

WHEREAS, this action will allocate CDBG funds to address sidewalk and traffic calming needs in CDBG eligible census tracts on "ready to construct" projects; NOW,
THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Chief Financial Officer is authorize to increase the Capital Improvements Program Budget in the amount not to exceed \$1,144,000, and to appropriate and expend an amount not to exceed \$1,144,000 from Community Development Block Grant (CDBG), Fund 600000, of which \$400,000 is for CIP A-BE.00001,

Americans with Disabilities Improvements, \$680,000 is for CIP A-IK.00001 New Walkways,
and \$64,000 is for CIP A-IL.00001 Traffic Calming.
