WHEREAS, the City Council in Closed Session on October 7, 2014, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of San Diego, that the council authorizes:

- 1. Authorizing the Mayor or his designee to pay the sum of \$365,000.00 from the Water Utility Operating Fund No. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of XL Specialty Insurance Co. v. City of San Diego, et al., San Diego Superior Court Case No. 37-2014-00030786-CU-EI-CTL.
- 2. Authorizing the Chief Financial Officer to appropriate and expend \$365,000.00 from the Water Utility Operating Fund, Fund 700011, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
