DATE OF FINAL PASSAGE DEC 12 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN INCREASE IN THE TASK ORDER AMOUNT FOR THE MULTIPLE AWARD DESIGN-BUILD CONTRACTS FOR THE CATALINA WATER AND SEWER PROJECT.

WHEREAS, on October 23, 2012, the Council of the City of San [Council] authorized the Mayor or his designee to execute multiple design-build contracts with five design-build entities, in which the design-build entities compete for public works projects on a task order basis pursuant to San Diego Municipal Code section 22.3310 (Resolution R-307739); and

WHEREAS, the design-build firms approved by the Council are as follows:

1. Orion Construction Corp. / Balboa Construction, Inc. in association with Harris & Associates and Richard Brady & Associates. (Document No. RR-307739-1);
2. El Cajon Grading & Engineering Company, Inc. in association with David Evans & Associates, Inc. (Document No. RR-307739-2);
3. J.R. Filanc Construction Company, Inc. in association with Arrieta Construction, Inc. and HDR. (Documents No. RR-307739-3);
4. Ortiz Corporation in association with AECOM. (Document No. RR-307739-4);  
and
5. TC Construction Company in Association with RBF Consulting. (Document No. RR-307739-5).


WHEREAS, San Diego Municipal Code section 22.3310(f) authorizes task orders in an amount not to exceed \$10,000,000 without City Council approval;

WHEREAS, an increase in the task order amounts will accelerate construction of sewer and water main projects in an area known for pipeline deterioration, and will improve sewer and water services in the community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Mayor, or his designee is authorized, for and on behalf of the City, to increase a task order to an amount not to exceed \$20,000,000 for the selected design-build firms for this project

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$20,000,000 to fund task orders to the selected firms for the awarded design-build contracts with three years in duration upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first finishing one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
