SAN DIEGO AUTHORIZING A SECOND AMENDMENT
TO THE AGREEMENT WITH LUTH & TURLEY FOR AS-
NEEDED WATER AND SEWER CLEAN-UP AND
REMEDIAION SERVICES.


WHEREAS, on November 27, 2012, the Mayor and City Council authorized the City to enter into an agreement with Luth & Turley for as-needed remediation and clean-up services resulting from water main breaks and sewer backups pursuant to City Council Resolution R-307850; and

WHEREAS, on July 7, 2014, the Mayor and City Council authorized the City to enter into the first amendment to the agreement with Bidder to incorporate prevailing wage requirements and increase the funds available under the agreement pursuant to City Council Resolution R-309075; and

WHEREAS, after the first amendment was approved, Luth & Turley identified other unanticipated impacts from implementing prevailing wage requirements that affects their originally proposed costs and overhead; NOW, THEREFORE;

BE IT RESOLVED, that the Mayor or his designee is authorized to execute, for and on behalf of the City, a second amendment to the agreement with Luth & Turley, Inc. for as-needed remediation and clean-up services as a result of damage caused by water main breaks and sewer backups, under the terms and conditions set forth in the Second Amendment to Memorandum of Agreement, on file with the City Clerk as Document No. RR- 309354.





