WHEREAS, on May 7, 2012, the City Council approved Resolution No. R-307414, which, among other things, authorized the City Attorney to appoint Orrick, Herrington & Sutcliffe LLP (Orrick) to assist the City Attorney to file and prosecute a judicial validation action on behalf of the City in relation to the formation of the Convention Center Facilities District (Validation Action); and

WHEREAS, on October 1, 2014, the Court of Appeal overturned the Superior Court's ruling in favor of the City in the Validation Action and the Mayor's Office requested that Orrick prepare a legal memorandum discussing a potential appeal to the California Supreme Court and to brief the City Council on such an appeal; and

WHEREAS, Orrick has provided the requested services and the City Council has determined that it is appropriate to compensate Orrick for such services in an amount of \$41,102.50; NOW, THEREFORE,

BE IT RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend up to a total amount of \$42,102.50 for Orrick for services rendered related to the Validation Action, contingent upon the City Comptroller first furnishing one or more certificates

certifying that the funds necessary for such ex	xpenditures are, or will be, on deposit with the City
Treasurer.
