A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO REAPPOINTING A MEMBER OF THE
SAN DIEGO UNIFIED PORT DISTRICT BOARD OF
COMMISSIONERS

WHEREAS, appointments to boards and commissions are governed procedurally by
Council Policy No. 000-13; and

WHEREAS, the Council Policy permits Councilmembers to recommend nominees for
appointments to those boards and commissions for which the Council has the power of
appointment; and

WHEREAS, the Council has the authority to appoint three residents of the City of
San Diego to the San Diego Unified Port District Board of Commissioners (the Board) to
represent the City on the Board; and

WHEREAS, commissioners serve four-year terms; and


WHEREAS, Commissioner Bob Nelson, whose term is expiring, has been recommended
for reappointment by Council President Todd Gloria, Councilmember David Alvarez and
Councilmember Mark Kersey, and no other nominations were submitted in response to a call for
nominations; and

WHEREAS, the Council President now requests Council confirmation of the
reappointment; and

WHEREAS, appointments and reappointments to the Board are not subject to mayoral
veto under the state law applicable to this Board; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Bob Nelson is hereby reappointed to the San Diego Unified Port District Board of Commissioners, to serve a four-year term that begins January 3, 2015 and ends January 2, 2019.
