A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE APPROVAL OF THE AWARD OF FUNDS TO OCEAN BEACH COMMUNITY DEVELOPMENT CORPORATION FOR VETERANS PLAZA IS EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15061(b)(3).

WHEREAS, the City proposes to award funds to Ocean Beach Community Development Corporation for the OB Veterans Plaza Project (No. 387452) (Project); and

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines (California Code of Regulations, Title 14, Chapter 3, Section 15000 et seq.) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, this activity is a Project under CEQA Section 15378(a)(1) and is exempt from CEQA pursuant to CEQA Guidelines Section 15061(b)(3) under the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment; and

WHEREAS, pursuant to CEQA Guidelines Section 15352(a), approval of this agreement and funding allocation does not constitute approval of the Project which is being reviewed by the Development Services Department in accordance with CEQA and the City's Land Development Code (LDC); and

WHEREAS, Project approval will not occur until the environmental review has been completed in accordance with CEQA Guidelines Section 15004; and

WHEREAS, the approval of the funding agreement will not foreclose review of

alternatives or mitigation measures by the public as part of the CEQA process; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has

determined that approval of the funding agreement will not have a significant effect on the

environment; NOW THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego determines that approval

of the funding agreement is exempt from CEQA pursuant to CEQA Guidelines section

15061(b)(3) under the general rule that CEQA applies only to projects which have the potential

for causing a significant effect on the environment.

BE IT FURTHER RESOLVED, that the Council of the City of San Diego has

determined that an exception to the exemption as set forth in CEQA Guidelines section 15300.2

does not apply.
