DATE OF FINAL PASSAGE DEC 09 2014

A RESOLUTION DECLARING THE RESULTS OF THE MUNICIPAL GENERAL ELECTION HELD IN THE CITY OF SAN DIEGO ON NOVEMBER 4, 2014.

WHEREAS, a Municipal General Election was held in the City of San Diego on Tuesday, November 4, 2014, pursuant to the provisions of Ordinance No. O-20383 (New Series), adopted July 14, 2014, for the purpose of electing candidates to the office of Councilmember for District 6; and

WHEREAS, the San Diego County Registrar of Voters canvassed the returns of the Municipal General Election and has certified the results to the City Clerk; and

WHEREAS, the City Clerk certified the results as of December 2, 2014 and presented the certification to the City Council; and

WHEREAS, declaring the results of the election as certified by the City Clerk is a ministerial act required by California Elections Code section 10263 and, therefore, is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council finds and determines, pursuant to the provisions of section 27.0411 of the San Diego Municipal Code, as follows:

I

The whole number of votes cast in the City was 32,086.

II

The total vote received by each municipal candidate at the municipal general election is as follows:

FOR THE OFFICE OF COUNCIL DISTRICT NO. 6 (four-year term)

Chris Cate	received	17,102 votes	53.30%
Carol Kim	received	14,984 votes	46.70%
Total for Office of Council District No. 6		32,086 votes	100.0%


Chris Cate is hereby declared to be elected to the Office of Council District 6 in the Municipal General Election.

II.

The City Clerk is directed to record the total number of votes cast in the City of San Diego, and the number of votes cast in each precinct for each candidate, in the Election Returns Book. The book is authorized and is considered to be a part of the record of this Council.

The City Clerk also shall make public the results of the canvass of the Municipal General Election by publication of a copy of this resolution.


