directed to execute, for and on behalf of the City, an Agreement with Big Brothers Big Sisters of

San Diego County in an amount not to exceed \$14,800 for the project described herein, under

terms and conditions set forth in the Agreement on file in the Office of the City Clerk as

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$14,800 from the Community Projects, Programs and Services budget

\$10,000 from Cost Center 1109110009

to provide funds for the above-referenced agreement, contingent upon the Chief Financial
