A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO AUTHORIZE AN AS-NEEDED
SERVICE AGREEMENT FOR BRUSH MANAGEMENT
SERVICES FOR CITY OPEN SPACE PROPERTY

WHEREAS, an Invitation to Bid for brush management services on an as-needed basis for City open space property was issued on October 3, 2014, and two companies submitted bids; and

WHEREAS, Aztec Landscaping, Inc. had the lowest responsive, responsible and reliable bid; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized and directed to execute, for and on behalf of the City, the Invitation to Bid/Contract (Cover Sheet), Addendum A (ITB No. 10051852-15-A) to Furnish the City of San Diego with Brush Management Services for Open Space Property Managed by the Park and Recreation Department with Aztec Landscaping, Inc. (As-Needed Services Contract), on file in the Office of the City Clerk as Document No. RR- 309406, under the terms and conditions set forth in the As-Needed Services Contract for as-needed brush management services having an initial term of one year, with four options to renew of one year each option, provided that the Chief Financial Officer first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer, for a total contract term of five years.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$10,991,000 over five years (\$1,563,206 in Fiscal Year 2015, and

\$1,923,000 in Fiscal Year 2016) from Fund No. 100000, Open Space Brush Management Program for the purpose of funding the As-Needed Services Contract, contingent upon adoption of the brush management budget and the Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.
