DATE OF FINAL PASSAGE DEC 12 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A CONTRACT WITH SECURITAS SECURITY SERVICES USA INC. FOR ENHANCED SECURITY GUARD SERVICES FOR THE PUBLIC UTILITIES DEPARTEMENT; AND TAKING RELATED ACTIONS.

WHEREAS, in March 2014, the City of San Diego issued IFB No. 10040659-14-J soliciting bids for the furnishing of Enhanced Security Guard Services at Public Utilities Department facilities for a contract term of one year with the option to extend for four additional annual periods; and


WHEREAS, the selection committee thoroughly reviewed, evaluated, and scored the responsive bids and determined that Securitas Security Services USA Inc. (Securitas) had the winning bid; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to enter into an agreement with Securitas for Enhanced Security Guard Services for the Public Utilities Department for a period of one (1) year , with options to renew for four (4) additional one (1)-year periods, for a maximum cumulative amount not to exceed \$13,719,961.92, in accordance with the terms and conditions of ITB No. 10040659-14-J, contingent upon the Chief Financial Officer first furnishing one or more certificates demonstrating that the funds are, or will be, on deposit in the City Treasury.
2. That the Chief Financial Officer is authorized to expend a cumulative amount not to exceed \$13,719,961.92, over a period of five years, of which \$7,491,055.03 is from Water Utility Operating Fund 700011, \$731,301.16 is from Muni Sewer Revenue Fund 700000, and

\$5,497,605.73 is from Metro Sewer Utility Fund 700001, to provide funds for the
aforementioned agreement with Securitas, contingent upon the adoption of the Annual
Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial
Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or
will be, on deposit with the City Treasury.
