A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING AN INCREASE IN THE FISCAL
YEAR 2015 CAPITAL IMPROVEMENTS PROGRAM
BUDGET FOR BUS STOP IMPROVEMENTS.

WHEREAS, in July of 2008 the City and the San Diego Metropolitan Transit System (MTS) entered into an agreement whereby the City would receive a portion of revenues derived from the sale of advertising on MTS bus shelters placed within the City's public right-of-way; and


WHEREAS, the agreement between the City and MTS requires that the revenues received by the City be used for bus stop improvements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer is authorized to increase in the Fiscal Year 2015 Capital Improvements Program Budget in CIP A-ID.00007, Annual Allocation – Bus Stop Improvements, Fund 400691 Bus Stop Capital Improvements; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$46,080.08 from CIP A-ID.00007, Annual

Allocation – Bus Stop Improvements, Fund 4000691 Bus Stop Capital Improvements, for the purpose of capital improvements in support of bus tops.


