BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer is authorized to increase in the Fiscal Year 2015 Capital Improvements Program Budget in CIP A-ID.00007, Annual Allocation - Bus Stop Improvements, Fund 400691 Bus Stop Capital Improvements; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$46,080.08 from CIP A-ID.00007, Annual Allocation – Bus Stop Improvements, Fund 4000691 Bus Stop Capital Improvements, for the purpose of capital improvements in support of bus tops.
