A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING ACTIONS RELATED TO AWARD OF A GRANT FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT FOR THE HEALTHY HOMES PROGRAM.

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) has grant funding available to reduce safety and health hazards that produce serious disease and injury to children in low-income environments; and

WHEREAS, the City previously received grant funding from HUD under its Healthy

Homes Demonstration Grant Program and is eligible to receive further grant funding; and

WHEREAS, subject to Council approval, such grant funding would be used for the City's Healthy Homes Program for purposes of identifying and eliminating lead hazards, as well as other environmental hazards that could adversely impact a child's health; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that that Mayor or his designee is authorized, for and on behalf of the City, to accept grant funding from the U.S. Department of Housing and Urban Development (HUD) in the amount of \$3,400,000 under the Lead-Based Paint Hazard Control Grant Program (Grant), for purposes of identifying and controlling lead hazards and other multiple residential health and safety hazards, and to negotiate, execute, and comply with the agreement with HUD for the Grant.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$3,400,000 from Fund No. 600000, Grant Fund – Federal, Cost Center 2115111112, for purposes of identifying and controlling lead hazards and

other multiple residential health and safety hazards, contingent upon receipt of a fully-executed Grant agreement.

BE IT FURTHER RESOLVED, that the Mayor or designee is authorized to take all necessary action to administer, monitor, and manage the Grant agreement with HUD, and when required, develop, advertise, negotiate and award contracts to third parties to implement the Grant agreement.
