WHEREAS, the County of San Diego, as lead agency under the California

Environmental Quality Act of 1970 (CEQA)(Public Resources Code section 21000 et seq.), as amended, prepared and adopted an Addendum to Negative Declaration No. SCH 2004091023; Project No. 48148 (Addendum), dated January 31, 2014, for the North San Diego County

Recycling Market Development Zone (RMDZ) renewal and expansion project (Project); and

WHEREAS, the County of San Diego, as lead agency, determined that there are no substantial changes to the Project or substantial changes with respect to the circumstances under which the Project is to be undertaken, which would involve new significant environmental impacts or substantially more severe significant impacts that were not considered in Negative Declaration No. SCH 2004091023; Project No. 48148 (Negative Declaration), dated November 8, 2004, which was prepared and adopted by the City of San Diego; and

BE IT RESOLVED, that the City Council of the City of San Diego, as a responsible agency under CEQA, has reviewed and considered the information in the Negative Declaration and Addendum, has considered the environmental effects of the Project as shown in the Negative Declaration and Addendum, and that the information contained therein reflects the independent judgment of the City of San Diego.

BE IT FURTHER RESOLVED, that the information contained in the Negative

Declaration and Addendum thereto has been reviewed and considered by this City Council prior to making a decision on the Project.

BE IT FURTHER RESOLVED, that there are no substantial changes proposed to the Project and no substantial changes with respect to the circumstances under which the Project is to be undertaken that would require major revisions to the Negative Declaration for the Project.

BE IT FURTHER RESOLVED, that no new information of substantial importance has become available showing that the Project would have any significant effects not discussed previously in the Negative Declaration, or that any significant effects previously examined will be substantially more severe than shown in the Negative Declaration.

BE IT FURTHER RESOLVED, that pursuant to CEQA Guidelines Section 15164, the City Council adopts the Addendum to the Negative Declaration with respect to the Project, a copy of which is on file in the Office of the City Clerk.
