A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN EXTENSION TO THE CONTRACT WITH CARTEGRAPH SYSTEMS, INC. FOR THE CITYWIDE STREET PAYMENT ASSESSMENT SURVEY AND AUTHORIZING THE EXPENDITURE OF FUNDS RELATED TO THE SURVEY.

WHEREAS, on January 11, 2011by Resolution No. R-306521, the Council authorized a one-year contract for an assessment of the City's pavement, which included options to renew the contract for up to four additional one-year periods; and

WHEREAS, the City wishes to exercise the fourth option of four yearly renewal options to renew the contract for the fourth additional year to provide for continuing services; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor, or his designee is authorize to execute a one-year option renewal with Cartegraph Systems, Inc. for consultant services to perform a citywide street pavement assessment survey under the terms and conditions set forth in Bid 10007110-11-P, on file with the City Clerk as Document No. RR-306521, for an amount not to exceed \$556,675.90.
- 2. That the Mayor, or his designee is to authorize the expenditure in the amount not to exceed \$556,675.90 from the Transportation & Storm Water Department (2116) in Fund 100000, General Fund, for the purpose of funding the agreement, contingent upon the Chief Financial

Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasury.
