DATE OF FINAL PASSAGE DEC 16 2014

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO ADOPTING TEMPORARY RULE 6.10.1 OF THE PERMANENT RULES OF THE COUNCIL RELATING TO THE COMMITTEE ON ECONOMIC DEVELOPMENT AND INTERGOVERNMENTAL RELATIONS.

WHEREAS, Rule 9 of the Permanent Rules of the Council provides that the Council President may, at any time, place on the Adoption Agenda a resolution establishing a temporary rule that, for the time being, has the effect of a standing rule; and

WHEREAS, Rule 9 further provides that if the temporary rule conflicts with a permanent rule, it shall supersede such permanent rule for such time as may be specified in the temporary rule; and

WHEREAS, due to the increase in the number of Council Committees and the responsibilities and duties that come with those assignments the Council desires to change the committee composition of the Committee on Economic Development and Intergovernmental Relations from five members to four members; and

WHEREAS, the change in committee composition may be accomplished by adopting a resolution under Rule 9 of the Permanent Rules of the Council; and

WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following temporary rule 6.10.1(a) of the Permanent Rules of Council is approved:


**6.10.1 Committee on Economic Development and Intergovernmental Relations**

- (a) The Committee on Economic Development and Intergovernmental Relations shall be composed of four voting members.

BE IT FURTHER RESOLVED, that temporary rule 6.10.1(a) shall supersede Permanent Rule 6.10.1(a) for one year or until the last meeting of the Committee in the month of December 2015, whichever is later.
