ORDINANCE NUMBER O- 20449 (NEW SERIES)

DATE OF FINAL PASSAGE JAN 20 2015

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXTEND THE CONTRACT WITH ROTORCRAFT SUPPORT, INC. FOR MAINTENANCE AND SUPPORT OF THE CITY'S FIRE-RESCUE DEPARTMENT HELICOPTERS.

WHEREAS, on September 7, 2010, the Council of the City of San Diego approved Resolution No. 306094, which authorized the City of San Diego (City) to enter into a contract with Rotorcraft Support, Inc. (RSI) for the provision of service maintenance to the two San Diego Fire-Rescue Department (SDFD) helicopters; and

WHEREAS, the SDFD Air Ops Division currently owns and operates one Bell 212 HP and one Bell 412 EP twin-engine gas turbine medium-lift helicopters; and

WHEREAS, both helicopters are outfitted for multi-mission emergency response in order to provide primary fire, rescue, and emergency medical services to citizens throughout San Diego County; and

WHEREAS, routine repairs, inspections, and maintenance are required on a continuous basis in accordance with manufacturer mandatory time and life schedules; and

WHEREAS, the City contracts with RSI to provide both scheduled and unscheduled maintenance to the aircraft; and

WHEREAS, the scheduled maintenance has been developed to provide an on-going and continual phase inspection and maintenance program; and

WHEREAS, the maintenance involves relatively small work items and inspections, intended to decrease the out of service time for each aircraft; and

WHEREAS, the on-going and continual phase inspection and maintenance program is preferable to two or three yearly large inspections that would place the aircraft out of service for an extended period of time; and

WHEREAS, the scheduled maintenance is provided on an as-needed basis and the maintenance provider is required to support the Air Operations Division with three fully qualified helicopter mechanics as well as to provide the parts necessary for each aircraft; and

WHEREAS, the purpose for requesting the extension is so that SDFD staff can complete the analysis necessary to determine whether the current contract scope of work needs to be amended; and

WHEREAS, it is expected that the evaluation will be completed by July 1, 2015; and

WHEREAS, there is no additional impact to the General Fund for the extension to June 30, 2016; and

WHEREAS, the yearly cost of this contract is part of the SDFD's anticipated needs and is accounted for in the yearly budget; and

WHEREAS, currently, the annual estimated cost for the helicopter service and maintenance is \$1,100,000; NOW, THEREFORE,


BE IT ORDAINED, by the Council of the City of San Diego (Council), as follows:

Section 1. That the Mayor, or his designee, is authorized to execute a First Amendment to Contract #4600000114 with Rotorcraft Support, Inc. for maintenance and support services that will extend the contract to June 30, 2016.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
