AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE TRANSFER OF A NON-EXCLUSIVE SOLID WASTE COLLECTION FRANCHISE FROM EXPRESS WASTE & RECYCLING, INC. TO EDCO DISPOSAL CORPORATION AND AUTHORIZING A CONSENT TO ASSIGNMENT OF THE EXPRESS WASTE & RECYCLING, INC. FRANCHISE AGREEMENT.

WHEREAS, Express Waste & Recycling, Inc. has a non-exclusive Class I franchise and franchise agreement with the City for the collection and management of solid waste; and

WHEREAS, Express Waste & Recycling, Inc. wishes to transfer its franchise to EDCO Disposal Corporation, a current solid waste collection and management franchisee within the City of San Diego; and

WHEREAS, the transfer of the franchise requires City Council approval under San Diego Charter section 103 and San Diego Municipal Code section 66.0120; and

WHEREAS, this item was heard by the Committee on the Environment on November 12, 2014, which unanimously recommended approval of this transfer; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the transfer of the Class I Non-Exclusive Franchise for Solid Waste Management Services from Express Waste & Recycling, Inc. to EDCO Disposal Corporation is hereby approved.

Section 2. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, a consent to the assignment of the franchise and the franchise agreement, as set forth in the Consent to Assignment of Class I Non-Exclusive Franchise Agreement for Solid Waste Management Services, on file with the City Clerk as Document No. OO-

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
