AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 2, DIVISION 1 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 22.0101 RELATING TO SELECTION OF THE COUNCIL PRESIDENT.

WHEREAS, San Diego Charter section 270 states that the Council shall determine its own rules and order of business, including a process for selecting a presiding officer to chair meetings of the Council and manage the docket process; and

WHEREAS, the City Council has adopted the Permanent Rules of the Council (Rules) which are codified in San Diego Municipal Code section 22.0101; and

WHEREAS, the City Council desires to amend Rule 4.2 relating to the selection of the Council President; and

WHEREAS, under Charter section 280(a)(1), this ordinance is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 2, Article 2, Division 1 of the San Diego Municipal Code is amended by amending section 22.0101, to read as follows:

§ 22.0101 Permanent Rules of the Council
