DATE OF FINAL PASSAGE FEB 20 2015

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CHIEF FINANCIAL OFFICER TO APPROPRIATE AND EXPEND \$185,654 ON THE EXISTING AGREEMENT WITH ACE PARKING MANAGEMENT, INC., FOR PARKING MANAGEMENT SERVICES AT THE EVAN V. JONES PARKADE

WHEREAS, pursuant to City Council Resolution No. 305550, the City of San Diego (City) entered into Contract No. 9105-08-Z-RFP/4600000157 (Agreement) in 2010 with Ace Parking Management, Inc., a California corporation (Ace), for parking management services at the City-owned Evan V. Jones Parkade located next to the Civic Concourse; and

WHEREAS, the five (5)-year term of the Agreement term will expire on February 17, 2015. The Agreement contains an option to extend the contract on a month-to-month basis, upon agreement of the parties; and

WHEREAS, the Real Estate Assets Department and Purchasing and Contracting Department are initiating a new Request For Proposals (RFP) process for a new Parkade parking management services contract. These Departments have indicated that the new RFP process and successor contract will not be completed for approximately one (1) year. To preserve continuity of Parkade parking management services during this time, the Departments have recommended that the month-to-month extension option of the Agreement be exercised; and

WHEREAS, the Agreement structure requires the City to pay for Ace's services at the Parkade. Under Resolution No. 305550, City expenditure on the Agreement was limited to the initial five year term. Accordingly, additional authorization is required for City expenditures during the month-to-month extension; and

WHEREAS, a public hearing was duly noticed and held in regard to the matters set forth in the recitals hereof; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:


Section 1. That the Chief Financial Officer is authorized to appropriate and expend funds up to \$185,654 from the Concourse/Parking Special Fund No. 200300 during Fiscal Years 2015 and 2016, for parking management services at the Evan V. Jones Parkade pursuant to Contract No. 9105-08-Z-RFP/ 4600000157 with Ace Parking Management, Inc., a California corporation, contingent on certification that funds necessary for the expenditures are, or will be, on deposit with the City Treasurer.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
