AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO EXEMPTING ONE COMMITTEE CONSULTANT POSITION IN THE COUNCIL PRESIDENT'S OFFICE FROM THE CLASSIFIED SERVICE OF THE CITY OF SAN DIEGO.

WHEREAS, on February 5, 2015, the City of San Diego (City)'s Civil Service

Commission reviewed a request from the San Diego City Council (Council) President's Office

(Office) to exempt one Committee Consultant position from the Classified Service; and

WHEREAS, the Committee Consultant will work in Council Administration to support the Council Committee on San Diego Charter (Charter) Review, which was established by the Council with approval of San Diego Resolution R-309346 (Dec. 8, 2014); and

WHEREAS, the Committee Consultant will be responsible for analyzing, studying, and evaluating the Charter, the Permanent Rules of Council, and open government; and

WHEREAS, this position is part of the Office reorganization, and is critical to effective management and operational functions of the Office; and

WHEREAS, Charter section 117(a)(17) states that the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council"; and

WHEREAS, on February 5, 2015, upon review of the duties and responsibilities of the one Committee Consultant position, as provided by the Council President, the Civil Service Commission determined that the one Committee Consultant position meets the standard set forth in Charter section 117(a)(17) to be placed in the Unclassified Service; and

WHEREAS, the determinations of the Civil Service Commission are set forth in a memorandum dated February 10, 2015, from Hadi Dehghani, Personnel Director, to the Honorable Council President and Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Council has received and reviewed a Memorandum from Personnel Director Hadi Dehghani, dated February 10, 2015, which documents that, on February 5, 2015, the City's Civil Service Commission reviewed and favorably commented on a proposal from the Council President to exempt from the City's Classified Service one Committee Consultant position in her Office. The Committee Consultant will be responsible for analyzing, studying, and evaluating the Charter, the Permanent Rules of Council, and open government.

Section 2. That pursuant to Charter section 117(a)(17), with the Civil Service Commission's review and approval, the Council now exempts from the Classified Service and declares to be in the Unclassified Service of the City one Committee Consultant position in the Council President's Office, performing the duties set forth in the February 5, 2015, Memorandum from Personnel Director Hadi Dehghani to the Honorable Council President and Council.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage. APPROVED: JAN I.
