DATE OF FINAL PASSAGE MAY 28 2015

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO AUTHORIZE A SECOND AMENDMENT TO
THE AGREEMENT BETWEEN THE CITY OF SAN DIEGO
AND SAN DIEGO GAS AND ELECTRIC COMPANY FOR
THE ENERGY EFFICIENCY LOCAL GOVERNMENT
PARTNERSHIP 2010-2015

WHEREAS, the State of California has made energy efficiency in buildings a policy priority to better manage the amount of energy consumed in the State and thereby conserve resources and reduce greenhouse gas emissions; and

WHEREAS, the California Public Utilities Commission (CPUC) oversees public funding for energy efficiency programs, one of which is the Local Government Partnership program by which local governments may administer programs and apply for their funding through their incumbent investor owned utilities; and

WHEREAS, past CPUC funding for Local Government Partnership energy efficiency programs has adhered to a triennial cycle until after 2015; and

WHEREAS, the City of San Diego (City) has entered Local Government Partnership Agreements with San Diego Gas & Electric Company (SDG&E) since 2006 and currently has such an agreement for years 2013 and 2014; and

WHEREAS, on March 26, 2010 the San Diego City Council approved Resolution R-305672 for an energy efficiency Local Government Partnership agreement with SDG&E for Program Years 2010-2012; and

WHEREAS, on May 16, 2013 the San Diego City Council approved Resolution R-308193 for a First Amendment to the energy efficiency Local Government Partnership agreement with SDG&E to provide funding for Program Years 2013-2014; and

WHEREAS, in Phase 1 of CPUC Rulemaking R.13-11-005 the Commission approved Local Government Partnership funding for Program Year 2015, after which year the Commission will move from a triennial funding cycle to a rolling portfolio format for energy efficiency programs; and

WHEREAS, the City of San Diego and SDG&E desire to enter into a Second Amendment to the 2010 Local Government Partnership agreement to provide funding for City-administered energy efficiency programs in Program Year 2015. NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor be and he is hereby authorized and empowered to execute, for and on behalf of said City, the Second Amendment to the agreement with SDG&E for the purpose of continuing the City of San Diego Local Government Partnership Energy Efficiency Program for Program Year 2015 under the terms and conditions set forth in the Second Amendment to Agreement on file in the Office of the City Clerk as Document No. OO-20486 together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

Section 2. That the Chief Financial Officer is authorized to accept for Program Year 2015 funds in an additional amount up to \$1,068,000.00 from the CPUC, via SDG&E, under its Local Government Partnership Program with the City, and to appropriate and expend such funds,

as determined by the Mayor or his designee in accordance with and subject to CPUC program guidelines for the following objectives as more specifically set forth in the Amendment:


- a) Design and consult and support for energy efficiency improvements in Municipal facilities and operations.
- b) Codes and Standards Updates.
- c) Community Education and Outreach.
- d) San Diego Regional Energy Partnership Programs.

Section 3. That the Mayor or his designee is hereby authorized, subject to CPUC guidelines and the San Diego Municipal Code to take all necessary actions to administer, monitor, and manage the Second Amendment to the Local Government Partnership Agreement with SDG&E and when required, develop, advertise, negotiate, and award contracts with third parties to implement the program components authorized by SDG&E.

Section 4. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.


