

ORDINANCE NUMBER O- **20502** (NEW SERIES)

DATE OF FINAL PASSAGE JUL 1 2015

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO REZONING 7.0 ACRES LOCATED IN OTAY MESA, WITHIN THE OTAY MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE CN-1-2 ZONE TO THE RM-2-5 ZONE, AND REPEALING ORDINANCE NO. O-18014 ADOPTED NOVEMBER 29, 1993, OF ORDINANCE OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That 7.0 acres located in Otay Mesa and constituting portions of the parcels identified by the Assessor's Parcel Numbers 645-060-3200, 645-060-3500, and 645-061-0500, within the Otay Mesa Community Plan area, in the City of San Diego, California, as shown on Zone Map Drawing No. B-4307, filed in the office of the City Clerk as Document No.

OO- **20502**, are rezoned from CN-1-2 into the RM-2-5 zone, as the zone is described and defined by San Diego Municipal Code Chapter 13, Article 1, Division 4. This action amends the Official Zoning Map adopted by Resolution R-301263 on February 28, 2006.

Section 2. That Ordinance No. O-18014 adopted November 29, 1993, of the ordinances of the City of San Diego is repealed insofar as the same conflict with the rezoned use of the land.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its final passage, and no building permits for development inconsistent with the provisions

of this ordinance shall be issued unless application therefore was made prior to the date of adoption of this ordinance.

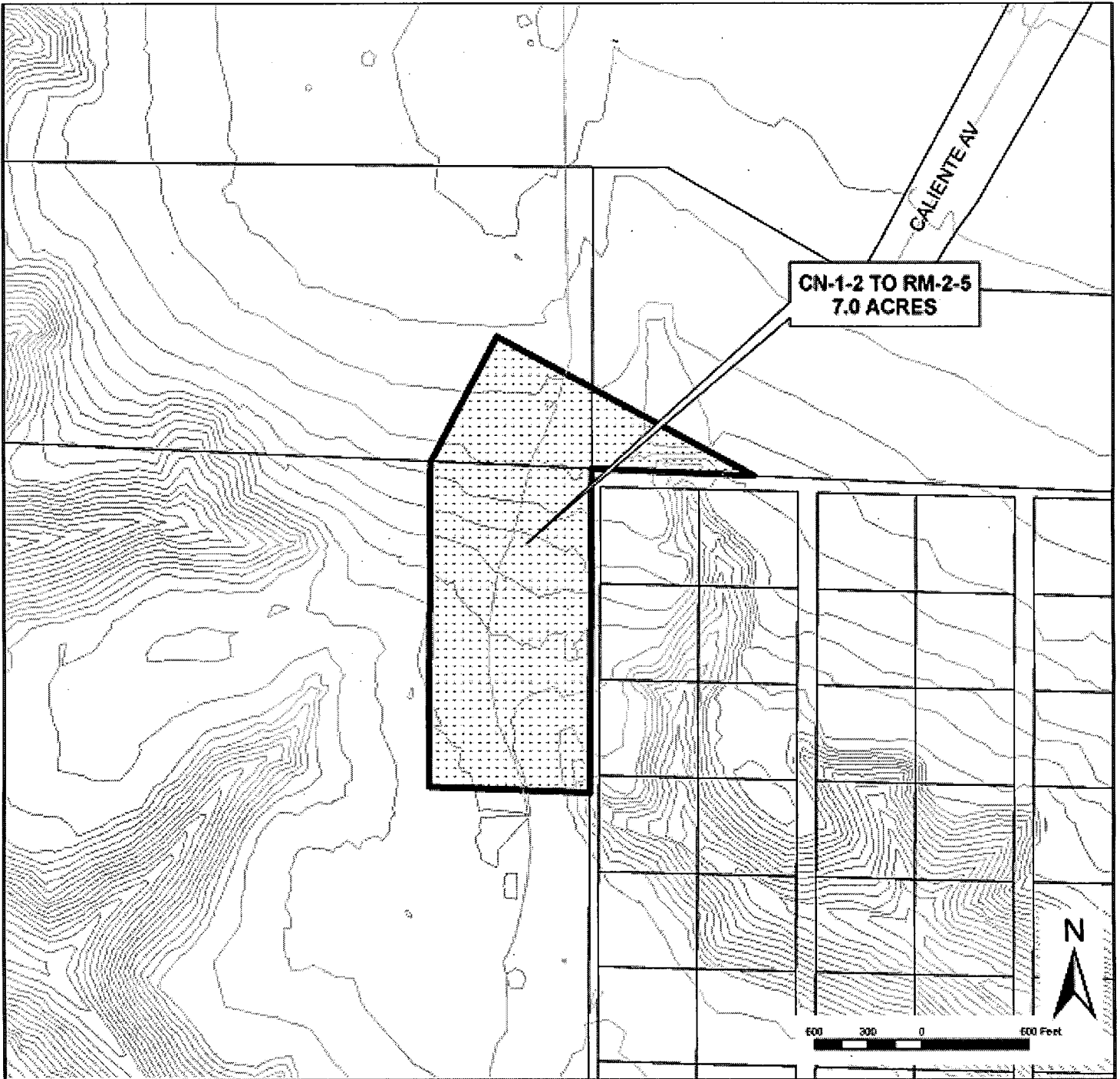
