AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO REZONING 14.7 ACRES LOCATED IN OTAY MESA, WITHIN THE OTAY MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE AR-1-1 ZONE TO THE CC-2-3 ZONE, AND REPEALING ORDINANCE NO. O-10862 ADOPTED JUNE 29, 1972, OF ORDINANCE OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That 14.7 acres located in Otay Mesa and identified by the Assessor's Parcel Number 645-040-4100, within the Otay Mesa Community Plan area, in the City of San Diego, California, as shown on Zone Map Drawing No. B-4304, filed in the office of the City Clerk as Document No. OO- 20504, are rezoned from the AR-1-1 zone into the CC-2-3 zone, as the zone is described and defined by San Diego Municipal Code Chapter 13, Article 1, Division 5. This action amends the Official Zoning Map adopted by Resolution R-301263 on February 28, 2006.

Section 2. That Ordinance No. O-10862 adopted June 29, 1972, of the ordinances of the City of San Diego is repealed insofar as the same conflict with the rezoned uses of the land.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its final passage, and no building permits for development inconsistent with the provisions


