

ORDINANCE NUMBER O- **20513** (NEW SERIES)

DATE OF FINAL PASSAGE JUL 1 2015

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF THE FIRST AMENDMENT TO THE AGREEMENT WITH KTU&A INC. FOR MISSION TRAILS REGIONAL PARK MASTER PLAN UPDATE/NATURAL RESOURCE MANAGEMENT PLAN AND ENVIRONMENTAL DOCUMENT AND EXTENDING THE AGREEMENT PAST FIVE YEARS.

WHEREAS, the Agreement with KTU&A INC for the Mission Trails Regional Park Master Plan Update/Natural Resource Management Plan and Environmental Document (“Agreement”) became effective on October 20, 2010; and

WHEREAS, Section 2.1 of the Agreement provides that it shall terminate upon completion of the Scope of Services or July 31, 2015, whichever is earliest but not to exceed five years unless approved by City ordinance; and

WHEREAS, additional time is required to complete the Scope of Services, and the parties agreed to an extension until July 31, 2017; and

WHEREAS, the extension is the only change to the Agreement; NOW, THEREFORE,

WHEREAS, under San Diego Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:


Section 1. That the Mayor or his designee is hereby authorized to execute for and on behalf of the City the First Amendment to the Agreement with KTU&A INC. for the Mission Trails Regional Park Master Plan Update/Natural Resource Management Plan and Environmental Document, which will extend the term of the Agreement until July 31, 2017,

under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. OO- **20513**

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
