AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO EXEMPTING ONE COUNCIL REPRESENTATIVE I IN COUNCIL DISTRICT 5 FROM THE CLASSIFIED SERVICE OF THE CITY OF SAN DIEGO.

WHEREAS, on April 2, 2015, the City of San Diego (City)'s Civil Service Commission reviewed a request from Council District 5 (Department) to exempt one Council Representative I position from the Classified Service; and

WHEREAS, the Council Representative I position will be responsible for interfacing with various entities on behalf of the Councilmember and providing constituent assistance; and

WHEREAS, San Diego Charter section 117(a)(17) states that the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council"; and

WHEREAS, on April 2, 2015, upon review of the duties and responsibilities of the Council Representative I position, as provided by the Department, the Civil Service Commission determined that the position meets the standard set forth in Charter section 117(a)(17) to be placed in the Unclassified Service; and

WHEREAS, the determinations of the Civil Service Commission are set forth in a memorandum dated April 6, 2015, from Hadi Dehghani, Personnel Director, to the Honorable Council President and Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Council has received and reviewed a memorandum from

Personnel Director Hadi Dehghani, dated April 6, 2015, which documents that, on April 2, 2015,

the City's Civil Service Commission reviewed and favorably commented on a proposal from the

Department to exempt one Council Representative I position.

That pursuant to Charter section 117(a)(17), with the Civil Service Section 2.

Commission's review and approval, the Council now exempts from the Classified Service and

declares to be in the Unclassified Service of the City one Council Representative I position in the

Department, performing the duties set forth in the April 6, 2015 memorandum from Personnel

Director Hadi Dehghani to the Honorable Council President and Council, and in this ordinance.

That a full reading of this ordinance is dispensed with prior to passage, a Section 3.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day

from and after its final passage.
