AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO EXEMPTING AN ASSISTANT DEPUTY DIRECTOR POSITION IN THE PUBLIC UTILITIES DEPARTMENT FROM THE CLASSIFIED SERVICE OF THE CITY OF SAN DIEGO.

WHEREAS, on June 17, 2015, the City of San Diego (City)'s Civil Service Commission reviewed a request from the Public Utilities Department (Department) to exempt an Assistant Deputy Director position from the Classified Service; and

WHEREAS, the Assistant Deputy Director will be responsible for ensuring that the Point Loma Wastewater Treatment Plan, North City and South Bay Water Reclamation Plants, and the Metro Biosolids Facility meet the system-wide state permit treatment performance requirements; and

WHEREAS, the Assistant Deputy Director will also oversee the operations of the Advanced Water Treatment Facility for the Pure Water Program; assist in formulating plans to achieve the mandatory water reduction targets at facilities; review policies and procedures; evaluate new technologies that either save water or create recycled water to meet the facilities' industrial water needs; and present reports to the Metro Joint Powers Authority and City Council on Metro Wastewater System updates; and

WHEREAS, San Diego Charter section 117(a)(17) states that the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority

and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council"; and

WHEREAS, on June 17, 2015, upon review of the duties and responsibilities of the Assistant Deputy Director position, as provided by the Department, the Civil Service Commission determined that the position meets the standard set forth in Charter section 117(a)(17) to be placed in the Unclassified Service; and

WHEREAS, the determinations of the Civil Service Commission are set forth in a memorandum dated June 17, 2015, from Hadi Dehghani, Personnel Director, to the Honorable Council President and Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Council has received and reviewed a memorandum from Personnel Director Hadi Dehghani, dated June 17, 2015, which documents that, on June 17, 2015, the City's Civil Service Commission reviewed and favorably commented on a proposal from the Department to exempt an Assistant Deputy Director.

Section 2. That pursuant to Charter section 117(a)(17), with the Civil Service Commission's review and approval, the Council now exempts from the Classified Service and declares to be in the Unclassified Service of the City an Assistant Deputy Director position in the Department, performing the duties set forth in the June 17, 2015 memorandum from Personnel Director Hadi Dehghani to the Honorable Council President and Council, and in this ordinance.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.
