AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO EXEMPTING TWO PROGRAM MANAGER POSITIONS IN THE PUBLIC UTILITIES DEPARTMENT FROM THE CLASSIFIED SERVICE OF THE CITY OF SAN DIEGO.

WHEREAS, on June 4, 2015, the City of San Diego (City)'s Civil Service Commission reviewed a request from the Public Utilities Department (Department) to exempt two Program Managers position from the Classified Service; and

WHEREAS, the first Program Manager will oversee Advanced Metering Infrastructure (AMI) and Field Services and will develop, direct, and manage citywide AMI implementation and operations; administer the citywide AMI Deployment project and subsequent AMI operations; and develop long-term policies and related procedures; and

WHEREAS, the second Program Manager will oversee External Water Policy and will be involved in the development of water policy initiatives at the San Diego County Water Authority (Water Authority); serve as a liaison to Water Authority staff and engage in various Water Authority sponsored stakeholder processes; work with the Department Director and the Intergovernmental Relations Department to determine related engagement activities; and develop a centralized system for assuring engaging and tracking Departmental activities as they relate to commenting on proposed regulations; and

WHEREAS, San Diego Charter section 117(a)(17) states that the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority

and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council"; and

WHEREAS, on June 4, 2015, upon review of the duties and responsibilities of the Program Manager positions, as provided by the Department, the Civil Service Commission determined that the positions meet the standard set forth in Charter section 117(a)(17) to be placed in the Unclassified Service; and

WHEREAS, the determinations of the Civil Service Commission are set forth in a memorandum dated June 11, 2015, from Hadi Dehghani, Personnel Director, to the Honorable Council President and Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Council has received and reviewed a memorandum from Personnel Director Hadi Dehghani, dated June 11, 2015, which documents that, on June 4, 2015, the City's Civil Service Commission reviewed and favorably commented on a proposal from the Department to exempt two Program Manager positions.

Section 2. That pursuant to Charter section 117(a)(17), with the Civil Service Commission's review and approval, the Council now exempts from the Classified Service and declares to be in the Unclassified Service of the City two Program Manager positions in the Department, performing the duties set forth in the June 11, 2015 memorandum from Personnel Director Hadi Dehghani to the Honorable Council President and Council, and in this ordinance.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shah	take effect and be in force on the infrieth day
from and after its final passage.
