DATE OF FINAL PASSAGE AUG 03 2015

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXTEND AN AGREEMENT WITH THE SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY FOR THE PROVISION OF EMERGENCY MEDICAL TECHNICIAN-PARAMEDIC SERVICES AT THE SAN DIEGO INTERNATIONAL AIRPORT AT LINDBERGH FIELD.

WHEREAS, the City has provided emergency medical technician-paramedic services to the San Diego County Regional Airport Authority (SDCRAA) pursuant to an agreement executed in 2010; and

WHEREAS, the City and SDCRAA wish to extend this agreement for two additional years, through June 30, 2017; and

WHEREAS, the remainder of the scope of services of the agreement shall remain unchanged; and

WHEREAS, this is a cost recoverable service, meaning that the City will submit invoices to SDCRAA and SDCRAA shall reimburse City for its costs in providing this service; and

WHEREAS, the City will then use SDCRAA's reimbursement to reimburse the City's emergency medical services provider, Rural/Metro Corp., for their costs associated with this agreement; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to extend the agreement between the City of San Diego and the San Diego County Regional Airport Authority for a period of two years, from July 1, 2015 through June 30, 2017, to provide emergency medical technician-paramedic services at the San Diego International Airport at Lindbergh Field.


Section 2. That the Chief Financial Officer, or his designee, is authorized to appropriate and expend funds to pay the City's emergency medical services provider, Rural/Metro Corp., for the subcontracted services associated with this agreement for FY 2016 and FY 2017, contingent upon adoption of the Annual Appropriations Ordinance for the applicable fiscal years and contingent upon the City Comptroller first furnishing one or more certificates stating that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.


