AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE THE SECOND AMENDMENT TO THE AGREEMENT WITH AECOM USA, INC. AECOM USA, INC. FOR THE MBC BIOSOLIDS STORAGE SILOS (9 & 10) PROJECT.

WHEREAS, the City of San Diego executed a consultant agreement with AECOM USA, Inc. (AECOM) for engineering design and construction support services for the MBC Biosolids Storage Silos (9 & 10) Project, CIP-S00322, a copy of which agreement is on file in the Office of the City Clerk as Document No. RR-304712 (Agreement); and

WHEREAS, under San Diego Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds' majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute the Second Amendment to the Agreement with AECOM USA, Inc. for additional construction support services in CIP-S-00322, MBC Biosolids Storage Silos (9 & 10) project, Fund 700009, Metro Sewer CIP, in an amount not to exceed \$54,330 contingent upon the adoption of the Fiscal Year 2016 Appropriation Ordinance and contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$54,330 from CIP S-00322, MBC Biosolids Storage Silos (9 & 10) project, Fund 700009,

Metro Sewer CIP, for purposes of executing the Second Amendment to the Agreement, contingent upon the adoption of the Fiscal Year 2016 Appropriation Ordinance and contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
