AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE SECOND AMENDMENT TO THE AGREEMENT WITH DUDEK & ASSOCIATES, INC. FOR ENVIRONMENTAL SERVICES ON THE FIRST SAN DIEGO RIVER IMPROVEMENT DREDGING PROJECT AND AUTHORIZING EXTENSION OF THE AGREEMENT PAST FIVE YEARS.

WHEREAS, the City of San Diego entered into an agreement with Dudek & Associates, Inc., dated May 19, 2006, for environmental services for the First San Diego River Improvement Dredging Project (FSDRIP) [Project] for an amount not to exceed \$70,450 [Agreement]; and

WHEREAS, the parties executed a first amendment to the Agreement, dated April 30, 2010, to increase the scope of work by including preparation of a Site Development Permit, for an additional amount of \$39,305; and

WHEREAS, the parties desire to further amend the Agreement to have Dudek & Associates, Inc. provide permit applications to various environmental and regulatory agencies, for an amount not to exceed \$95,960; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the second amendment to the Agreement, for an amount not to exceed \$95,960, under the terms and conditions set forth in the document on file in the Office of the City Clerk as Document No. OO- 20563

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$95,960 from CIP S-00606, SD River Dredging Qualcomm Way to SR 163, Fund 200054, First San Diego River Imp., for the purpose of executing the aforementioned second amendment to the Agreement, contingent upon the Chief Financial Officer first demonstrating funds necessary for expenditure are, or will be, on deposit with the City Treasury.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
