

ORDINANCE NUMBER O- 20565 (NEW SERIES)

DATE OF FINAL PASSAGE OCT 06 2015

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO REGARDING THE COMPENSATION OF THE INDEPENDENT BUDGET ANALYST.

WHEREAS, the San Diego City Council (Council) recently conducted the annual performance evaluation for Andrea Tevlin, the City's Independent Budget Analyst (IBA); and

WHEREAS, under San Diego Charter (Charter) section 70, the Council has the power to fix the salaries of "officers under its jurisdiction," including the IBA; and

WHEREAS, in accordance with Charter section 11.1, the Council annually adopts an ordinance establishing salaries for all City employees; and

WHEREAS, on April 21, 2015, the Council adopted the City's Salary Ordinance for Fiscal Year 2016, by San Diego Ordinance O-20484 (Apr. 21, 2015), and the Salary Ordinance includes ranges of compensation for officers and employees in the classification of Executive IV of the Unclassified Service, which includes the IBA; and

WHEREAS, as described in Council Policy 300-04, the Council considers efficiency, responsibility, merit, salaries paid by other agencies, and the City's financial situation, when setting the salary for the IBA; and

WHEREAS, over the past nine and one-half years, the Office of the IBA has been an integral component of the City's transition to the Strong Mayor/Council form of governance; and

WHEREAS, the IBA has been extremely valuable in improving transparency, accountability and responsiveness in the City's legislative and budgetary processes; and

WHEREAS, in recognition of her outstanding performance, the Council desires to approve a salary increase for the IBA; and

WHEREAS, under Charter section 280(a)(1), this ordinance is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,


BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. Upon the effective date of this ordinance, the annual salary of the Independent Budget Analyst is set at \$224,099 plus fringe benefits, consistent with those benefits received by officers and employees in the Executive IV classification of the Unclassified Service, as established by the Council, by adopting San Diego Ordinance O-20484, on April 21, 2015.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this Ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
