AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO EXEMPTING TWO PROGRAM MANAGER POSITIONS FROM THE CLASSIFIED SERVICE OF THE CITY OF SAN DIEGO.

WHEREAS, on September 3, 2015, the City of San Diego (City)'s Civil Service

Commission reviewed a request from Honorable City Council President Sherri Lightner (Council

President) to exempt two Program Manager positions from the Classified Service; and

WHEREAS, the first Program Manager position will be responsible for overseeing Information Technology (IT)-related functions of the City Council, Council Administration, and Office of Independent Budget Analyst, which include administering IT policy and recommending critical procedural and functional IT changes; and

WHEREAS, the second Program Manager position will be responsible for reviewing current policies and procedures and San Diego Municipal Code provisions related to City Council Committees and recommending revisions and developing new procedures, as needed; and

WHEREAS, San Diego Charter section 117(a)(17) states that the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council"; and

WHEREAS, on September 4, 2015, upon review of the duties and responsibilities of the Program Manager positions, as provided by the Council President, the Civil Service Commission determined that the two Program Manager positions meet the standard set forth in Charter section 117(a)(17) to be placed in the Unclassified Service; and

WHEREAS, the determinations of the Civil Service Commission are set forth in a memorandum dated September 4, 2015, from Hadi Dehghani, Personnel Director, to the Honorable Council President and Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Council has received and reviewed a memorandum from Personnel Director Hadi Dehghani, dated September 4, 2015, which documents that, on September 3, 2015, the City's Civil Service Commission reviewed and favorably commented on a proposal from the Council President to exempt two Program Manager positions from the Classified Service. The first Program Manager will be responsible for overseeing IT-related functions of the City Council, Council Administration, and Office of the Independent Budget Analyst. The second Program Manager will be responsible for reviewing current policies and procedures and San Diego Municipal Codes related to City Council Committees and recommending revisions or new procedures, as needed.

Section 2. That pursuant to Charter section 117(a)(17), with the Civil Service Commission's review and approval, the Council now exempts from the Classified Service and declares to be in the Unclassified Service of the City two Program Manager positions, performing the duties set forth in the September 4, 2015 memorandum from Personnel Director Hadi Dehghani to the Honorable Council President and Council, and in this ordinance.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
