AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE THIRD AMENDMENT TO THE AGREEMENT WITH WLC ARCHITECTS, INC. FOR THE EAST MISSION VALLEY, FIRE STATION NO. 45 (FORMERLY FIRE STATION NO. 2).

WHEREAS, Fire Station No. 45 (Project) is a brand new facility servicing the East Mission Valley area; and

WHEREAS, WLC Architects, Inc. was selected in accordance with Council Policy 300-7, and entered into an agreement with the City of San Diego on April 16, 2002, on file as Document No. RR-296360; and

WHEREAS, on February 1, 2005, the City entered into the First Amendment to the Agreement with WLC Architects, Inc. on file as Document No. RR-300104; and

WHEREAS, on May 19, 2011, the City entered into the Second Amendment to the Agreement with WLC Architects, Inc. on file as Document No. OO-20022; and

WHEREAS, the proposed Third Amendment to the Agreement with WLC Architects,

Inc. is required to cover unanticipated costs associated with increases to the Project scope and the

need to update plans to meet new building code requirements; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

VALLEY-URBAN, for the purpose of executing the Third Amendment to the Agreement with

WLC Architects, Inc. contingent upon the Chief Financial Officer furnishing a certificate

certifying that funds necessary for the expenditure are, or will be, on deposit with the City

Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a

the day of its passage.
